FOR THE TERM OF ONE (1) YEAR FROM THE CONTRACT DATE BELOW, CLIENT AUTHORIZES THOMSON HOLDINGS ENTERPRISES, LLC, DBA VOLUSIA COUNTY TOWING (HEREIN AFTER REFERRED TO AS VCT) AND ITS AGENTS TO REMOVE ANY AND ALL UNAUTHORIZED VEHICLES IN ACCORDANCE WITH THE PROVISIONS OF FLORIDA STATUTES 715.07 & 713.78. THIS CONTRACT RENEWS AUTOMATICALLY FOR AN ADDITIONAL YEAR AND LIKEWISE FOR EVERY YEAR THEREAFTER. THE ABOVE REFERENCED INDIVIDUALS WILL BE PRINCIPALLY DESIGNATED PERSONS RECOGNIZED BY THIS AGREEMENT TO ASSIGN VCT TO LAWFULLY REMOVE ANY AND ALL UNAUTHORIZED VEHICLES FROM THE REFERENCED SITE. **THIS IS A NON-BINDING CONTRACT THAT CAN BE CANCELLED AT ANY TIME WITH A 30 DAY WRITTEN NOTICE.** THIS AGREEMENT WILL SERVE AS CLIENT'S AUTHORIZATION FOR VCT TO ACT AS ITS AGENT IN THE REMOVAL ON SIGHT OF ANY AND ALL UNAUTHORIZED VEHICLES THAT ARE COVERED BY THIS CONTRACT. CLIENT REPRESENTS AND WARRANTS THAT IT HAS THE RIGHT TO AUTHORIZE AND EFFECT SUCH IMMEDIATE REMOVAL OF VEHICLES FROM ITS PREMISES. FURTHERMORE, CLIENT AGREES TO INDEMNIFY AND HOLD VCT HARMLESS FROM AND AGAINST ANY AND ALL CLAIMS, ACTIONS, LAWSUITS, LOSSES, DAMAGES AND/OR LIABILITIES, INCLUDING ATTORNEY'S FEES AND COSTS OF DEFENSE, WHICH MAY ARISE PURSUANT TO THIS AGREEMENT, EXCEPT IN THE CASE OF ANY DAMAGES TO A VEHICLE CAUSED SOLELY BY THE GROSS NEGLIGENCE AND/OR ILLEGAL CONDUCT OF VCT.
